2002 er udråbt til det internationale bjergår, og Europa-Kommissionen har derfor taget initiativ til en konference om «**EU-politikkerne og bjergområderne**», som afholdes torsdag den 17. og fredag den 18. oktober 2002 i Bruxelles i Kommissionens Charlemagne-bygning.

Der forventes ca. 500 deltagere, som repræsenterer de nationale og regionale myndigheder, EU-institutionerne, sammenslutningerne for bjergområderne og landbrugets organisationer og foreninger. Konferencen åbnes med en plenarsamling under forsæde af Kommissionens formand, Romano Prodi.

Konferencen giver mulighed for at fremlægge konkrete eksempler på god praksis og indhente kommentarer fra aktørerne i marken med henblik på udformningen af regionalpolitikken efter 2006.

Programmet, jf. vedlagte udkast, vil omfatte tre parallelle workshopper om følgende emner:

- regionalpolitikken og fysisk planlægning
- landbrugets udfordringer i bjergområderne
- kommunikation og livsrammens kvalitet.
