Folketingets Europaudvalg har ved skrivelse af 29. november 2002 udbedt sig besvarelse af nedenstående spørgsmål (alm. del – bilag 290):

Spørgsmål 28:

”Ministeren bedes oplyse, hvem der er de 10 største modtagere af EU's landbrugsmidler i hver af de 15 medlemslande samt hvor stor en procentdel af landbrugsstøtten i pct. samt i det reelle beløb i Euro, der blev udbetalt til disse modtagere i 2000 og 2001.”

Svar:

Det antages, at der med spørgsmålet menes de 10 største modtagere af direkte støtte, som defineret i bilaget til Rådets forordning nr. 1259/1999. Ifølge Direktoratet for FødevarerErhvervs oplysninger udgjorde de 10 største modtageres andel af den samlede direkte støtte i Danmark henholdsvis 0,68 pct. (5.011.285 €) i produktionsåret 2000 og 0,65 pct. (5.220.319 €) i produktionsåret 2001. Der henvises endvidere til vedlagte oversigt med yderligere oplysninger fra Direktoratet for FødevarerErhverv om de 10 største modtagere af direkte støtte i Danmark i produktionsårene 2000 og 2001.

For så vidt angår fordelingen af den direkte støtte i de 14 andre medlemslande i EU offentliggjorde Kommissionen den 1. oktober 2002 en pressemeddelelse MEMO/02/198 om fordelingen af den direkte støtte i EU undtagen i Grækenland. Kommissionens oversigt (aneks 2) omfatter dog ikke alle direkte støtteordninger, som defineret i bilaget til Rådets forordning nr. 1259/1999, men alene den direkte støtte, der udbetales direkte til støttemodtageren og ikke indirekte som eksempelvis tobak. Hovedkonklusionerne var, at mindre end 2000 støttemodtagere modtog mere end 300.000 € pr. år. Ca. 50 pct. af støttemodtagerne modtog under 1.250 €, samt at ca. 5 pct. af støttemodtagerne modtog mere end 50 pct. af den direkte støtte. Der henvises endvidere til den vedlagte pressemeddelelse fra Kommissionen.

Commission publishes indicative figures on the distribution of direct farm aid

The Commission has today transmitted indicative figures on the distribution of direct farm payments by size-class of aid received for the Financial Year 2000 to the Budgetary Control Committee, the Budget Committee and the Agriculture Committee of the European Parliament. The figures have been derived from the EAGGF (European Agricultural Guarantee and Guidance Fund) payment data received from the Member States. For obvious reasons, direct payments in the year 2000 reflect a situation predating the Agenda 2000 reforms or the proposals of the Mid Term Review. While in general data quality is adequate for use in the clearance of accounts activity, care must currently be exercised over use of the data for other, analytical purposes. Not all Member States currently employ a "system for unique identifiers" for all beneficiaries. Therefore, at present, the totals by beneficiary may be inaccurate, which is leading to "indicative" and not totally precise figures. As a precaution each Member State has been asked to confirm that the orders of magnitude of the statistics for their country appear broadly correct.

THE FIGURES IN DETAIL

1) Analysis of arable crops and livestock premia based on IACS data for all 15 Member States

The key figures are:

IACS EU-15:

Payments: 20.734 Bio €

Beneficiaries: 3.135 Mio

Key results:

- less than 2000 producers receive more than 300 000 €
- about 50 % of beneficiaries receive less than 2 000 €
- about 70 % of beneficiaries receive less than 5 000 €
- 7 % of beneficiaries receive 50 % of payments.

2) All direct payments for 14 Member States except Greece

As Greece could not supply sufficiently detailed information for all measures falling under this direct payments regime, an analysis of all direct payments for 14 Member States (and thus excluding nearly 1.000.000 olive oil beneficiaries of Greece) has been made.

The key figures are:

Direct payments EU-14:

(excluding Greece)

Payments: 22.365 Bio €

Beneficiaries: 4.459 Mio

Key results:

- less than 2000 producers receive more than 300 000 €
- about 50 % of beneficiaries receive less than 1 250 €
- about 5 % of beneficiaries receive 50 % of payments.

NOTE:

According to the formal definition given in Reg. (EC) No 1259/1999, "direct payments" accounted for 25.462 bio € in 2000. However, for some measures, these direct aids are not directly paid to the final beneficiaries, but to producer associations, which distribute the money further over their associates. In these cases, the Commission does not necessarily have information on final beneficiaries. In the case of Tobacco this mechanism is inherent because of the requirement to modulate 20 % of the premia to reflect "quality". The related budget items have thus been excluded from the attached tables. This applies for instance to tobacco premiums (almost 1 Bio €). Furthermore, for simplification reasons, some agri-monetary aids have also been paid globally and not to the final beneficiaries directly, which forced us to exclude these aids from the tables (167 Mio € for Italy).
