**Public Hearing: 'Respect for fundamental rights:  
the situation within the European Union in 2002'**

### Draft programme

For the third consecutive time, the European Parliament is organising a hearing of national parliament representatives with a special interest in respect for the fundamental rights enshrined in the European Union Charter of Fundamental Rights.

Since 2001, the European Parliament has presented an annual report on the situation of fundamental rights within the European Union which follows the structure of the Charter and is based on all available information sources (United Nations, Council of Europe, specialised European Agencies, NGOs).

Moreover, following its resolution of 5 July 2001, the European Parliament called on the Commission to create a European network of 15 national experts in the field of fundamental rights. The network has been operational since October 2002.

Although the national parliaments' procedures for dealing with such issues differ, examination of respect for our common democratic values remains without doubt a key parliamentary responsibility. The European Parliament therefore wishes to strengthen cooperation with national parliaments in this area.

This is all the more important since fundamental rights are eventually to become legally binding. Similarly, following the entry into force of Article 7(1) (new) of the Treaty of Nice, the European Parliament, together with the Commission and the Member States, could be involved in implementing an early warning system to prevent serious violations of human rights in Member States.

Following opening statements by the European Parliament, the Presidency-in-Office of the Council, the Commission and the Council of Europe Representatives, the morning will be devoted to hearing the NGOs concerned and the afternoon the national Parliaments representatives concerning the situation regarding fundamental rights in the EU and the main issues in 2002, which will be the subject of the next EP report by rapporteur, Mr Fodé Sylla. Adoption of the report is likely to take place at the September 2003 part-session.

The aim of the hearing is to highlight violations and the shortcomings of our policies in this area, as well as to examine and encourage best practice as applied in some Member States in order to create a genuine European area of freedom, security and justice. Mr Fodé Sylla's preliminary draft report and the summary report of the network of national experts drawn up by its coordinator, Mr Olivier De Schutter, will serve as a basis for the discussion.

*Due to time constraints and given the wide range of issues to be covered, members of national parliaments are asked to limit their presentations to five minutes so as to enable an exchange of views to be held with their EP colleagues.*

*More detailed written contributions (ten pages max.), which will be welcomed by the rapporteur, may of course be submitted provided that texts are forwarded to the secretariat (in FR and/or EN) no later than 4 April; similar conditions apply to written contributions by NGO representatives on the understanding that their oral statement may not exceed five minutes.*
