Delegations are invited to submit to the Presidency <u>before the 20th of October 2003</u>, non-institutional questions they wish to be raised, including those related to Part III of the draft Constitution. Some of these questions have already been mentioned: Christian values, minorities, economic governance. The Presidency reminds delegations however that in order to keep the discussions on the right track, a high degree of self-discipline is needed, therefore the issues raised should be limited, as far as possible, to the strict minimum. At the same time, the Presidency will welcome drafting proposals relating to these issues.
