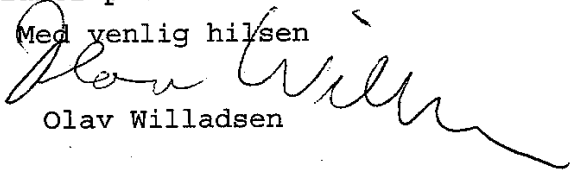
Jeg søgte under de europæiske Europaretssammenslutningers

Vesteuropæiske værdier vil derefter kun have historisk
interesse og kan fjernes fra EU-komplekset af disse to

THE FORBIDDEN SPEECH.

Speech that I intended to keep at the FIDE-congress in Dublin on June 5th 2004 in Dublin as part of the debate about the coming EU-constitution, but where president Skouros, chairman, accepted no words from the floor, even I protested.

Mr. president, Ladies and gentlemen, Dear friends and colleagues!

My name is Olav Willadsen, private practising advocate in Denmark - in a suburb to Copenhagen.

This very meeting began with a view 22 years back to the former FIDE-congress in Dublin.

On this last day of the congress, let me give you a look forward to the FIDE-congress in 50 years time:

Ladies and gentlemen:

The subject of FIDE 2054:

First:

A debate about the voting rights in the council and members of the Parliament - probably the big states demand - as they in some way will demand at the EU-constitution-debate in Dublin in 2004 - votes and members in the same size as they have inhabitants.

Second:

The growing population in high fertile member and neighbour states demand housing in open land and nature in EU.

Third:

Schengen problems with the EU border to Outer Mongolia.

The two dominant countries in EU: Turkey and Russia with 200 million inhabitants each, decide through the unofficial Moscow-Ankara cooperation the very important things.

After Turkey with 66 million inhabitants joined EU, it had with its present birthrate doubled its inhabitants in 30 years and reached 200 million in 2054.

As the psychically and inhabitant number biggest European state it was impossible to keep Russia out, and Russia joined the community too and had 200 million inhabitants in 2054.

The old big states tries through a sort of Visegrad work to keep the remnants of their power and the Turkish and Russian politicians listen politely until they themselves make the decisions.

The maybe coming constitution does not look at demography - only on democracy - and that will make it live much shorter than the treaty of Rome.
