Act on Protection of Cultural Assets in Denmark</p> <p>The Act on Protection of Cultural Assets in Denmark came into force on 1 January 1987. According to section 2(1) in the Act on Protection of Cultural Assets in Denmark the Act applies to the following cultural assets which are not publicly owned:</p> <ul style="list-style-type: none"> <li>• cultural objects of the period before 1660;</li> <li>• cultural objects older than 100 years and valued at DKK 100,000 or more;</li> <li>• photographs (regardless of age) if they have a value of DKK 30,000 or more.</li> </ul> <p>In exceptional cases the Minister of Culture can decide that the Act is also applicable to other objects of cultural interest.</p> <p>Coins and medals are the only cultural objects explicitly exempted from the regulations of the Act.</p> <p>The above-mentioned assets must not be exported from Denmark without permission</p>
